

76. Pursuant to authority contained in paragraph 2, Army Regulations 35-1480, dated 10 October 1942, the following-named Second Lieutenants, Air Corps, AUS, each of whom holds an aeronautical rating, are hereby required to participate in regular and frequent aerial flights at such times as they are called to active duty with the Army Air Forces, U. S. Army, under competent authority, and are authorized to participate in regular and frequent aerial flights while on an inactive status, in accordance with the provisions of paragraph 52, Army Regulations 95-15, dated 21 April 1930, effective 30 August 1943: (Class SE 43-H, Stuttgart, Arkansas.)


